Have you heard?

- ⇒ Thanks to all the site reps and retirees who helped with the TA ratification voting. I am so proud that 100% of sites returned the ballots on time, and nearly 83% of certificated staff voted within the short window. The pay raise appears in the check at the end of February, but remember that the retroactive pay will appear in the paycheck at the end of March. Thanks also goes to the OUEA Bargaining Team for the great work on the contract negotiations—way to go!
- ⇒ The Friedrichs v. CTA case is awaiting the decision by the Supreme Court. Hundreds of amicus briefs have been filed and both sides presented oral arguments to the Supreme Court Justices on January 11, but the court has until June 30 to rule on the case. CTA.org has information and resources to better understand the issues of the case and the need for a Fair Share system.
- ⇒ The OUEA Retirees are offering scholarships for up to \$1000.00 to help with continuing education. Applicants must have permanent employee status with at least three years of experience in OUSD. Information and applications should be posted at each site, and they are also available in the OUEA office.
- ⇒ There will be three OUSD Board of Educaton seats up for election in November 2016. Trustee Area 2 seat, currently held by John Ortega, covers the area including Lampson, Sycamore, West Orange, and Portola Middle School. Trustee Area 3 seat, currently held by Alexia Deligianni, covers the area including Crescent, Fletcher, Nohl Canyon, Olive, and Taft. Trustee Area 6 seat, currently held by Mark Wayland, covers the area including Cambridge, California, Handy, Yorba Middle School, Orange High School, and Richland High School. If you know people (parents, retired teachers, teachers who work at other school districts) that live in these areas and would make a good Board of Education member, let us know!



Know Your Contract

6.310 Elementary unit members shall not be required to attend more than ninety (90) minutes monthly of faculty meetings. Additional meeting time required beyond the monthly ninety (90) minutes shall be compensated at the miscellaneous hourly rate of pay.

The District and OUEA affirm that staff meeting dates for the year shall be mutually determined by the staff and the site/department administrator at the beginning of the school year. This determination shall include the specific dates and times of meetings for that year. Offschedule meetings may be conducted in unusual situations determined by the site administrator. Meetings shall be conducted in an orderly manner utilizing a written agenda for the meeting.

When I began teaching at Canyon High School in September of 1997, I was fortunate to have veteran teachers to answer my many questions and guide me. I also think that being in the classroom gives me more credibility when addressing member concerns with the district office.

Now I'm in a position to answer the questions of other educators, and I think back to that first year when I was new and clueless. I have always enjoyed the opportunity to share my enthusiasm for language and literature with my students; now I also enjoy sharing my enthusiasm for public education with my fellow educators.
